Bidding documents may be purchased from the office of the Medical Superintend, Bharatpur Hospital, Bharatpur. on submission of a written application, attested copies of registration firm valid for F/y2068/069, VAT Registration certificate, Tax clearance certificate of F/Y 2067/68 and upon payment of a non-refundable fee as shown on the above table within the office hours up to 30<sup>th</sup> day of first publication. Interested eligible Bidders must visit e-procurement section of Bharatpur Hospital Web Site <http://www.bharatpurhospital.gov.np> of eProcurement System and download the PQ Document.
3. Bids must be submitted to the Bharatpur Hospital, Bharatpur on or before office hour of 31<sup>th</sup> day of first publication. Bids shall be sealed in an envelope addressing to the Medical Superintend, Bharatpur Hospital, Bharatpur, indicating name of the contract, contract identification number, bidder's name and address. Alternatively, bidders may submit their Bids electronically through e-procurement section of Bharatpur Hospital's Web Site <http://www.bharatpurhospital.gov.np> as specified in the instruction to Bidders. PQ Documents received after this deadline shall not be accepted. Bids must be submitted hard copy with **user name** and **password** to the bharatpur hospital on 12.00 hrs 32<sup>th</sup> day of first publication in the opening time. If contractors not provided **user name** and **password** otherwise open the document office's user name and password.
4. A Bidder may submit the Bid only once either independently or in the form of joint venture (J/V) with another firm. To facilitate contract administration the maximum number of J/V partner is limited to 3.
5. Bids shall be opened in the presence of Bidders representatives who choose to attend at 12:30 hrs 32<sup>th</sup> day of first publication at the Medical Superintend's office, Bharatpur Hospital, Bharatpur. Bids must be valid for a period of 30 days

after bid opening and must be accompanied by bid security, amount minimum to above stated (inclusive of VAT), which shall be valid for 90 days from the date of Bid opening.

6. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Dharauti Account no 1310203000000 of District treasury controller office at Ra. Ba. Bank Ltd., Chaubiskothi, Bharatpur and should submit the original receipt of the deposited amount of cash along with the Bid.

For the purpose of Bidders who choose to submit their bid electronically through E-procurement section of Bharatpur Hospital's Web Site, <http://www.bharatpurhospital.gov.np> the Bidders may purchase the hard copy of bidding documents or may choose to download the necessary part of bidding PQ documents, prepare their bids and submit their electronic bids as specified in the instructions to Bidders. In case the Bidder choose to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding PQ document (as specified in the above table) in the office's (revenue) account as specified in the Notice and electronic scanned copy (PDF format) of the Bank deposit voucher also should be submitted along with the electronic bid documents.


