1. Bharatpur Hospital invites Sealed Bids from registered eligible Suppliers having qualification as mentioned in the TOR for the following contracts as mentioned below .
2. Bidding documents may be purchased from e-Procurement System by eligible Bidders upon submission of a written request attaching duly attested copies of Bidder's registration, VAT registration with the TAX clearance certificate up to the Fiscal year 2069/070 and upon the payment of a non refundable fee as mentioned below on or before 15 days of first day of publication of this notice for CR cassette imagine plate (tender no. 13) and before 30 days of first day of publication of this notice for Geriatric ward equipments (tender no. 14). Bidder's representative who wishes to purchase the Bids Documents shall furnish identity letter issued by the authorized person of the firm. For the bidder who will submit their bids in the form of electronic version, should attach the receipt of bids document purchase non-refundable fee deposited in the account stated below
3. The purchase bids documents shall be sealed in an envelope addressing to the Bharatpur Hospital indicating name of Tender Code, Tender Name, bidder's Firm Name and its address. The bids must be submitted to Bharatpur Hospital latest by 12:00 hrs on 16th day of the first date of publication of this notice for CR cassette imagine plate (tender no. 13) and 31st days of first day of publication of this notice for Geriatric ward equipments (tender no. 14). Documents received after this deadline will not be accepted.
4. The accepted bids shall be opened at Bharatpur Hospital in the presence of the Bidder's Representatives who choose to attend at 14: 00 hrs on the last date of submission. Non-attendance of any or the Bidder's entire Representative shall not obstruct the opening of the Bids.

5. In case of last date of purchasing of bids documents fall on government holiday then the purchasing can be made on the next working day. Similarly, if the last date of submission falls on government holiday then submission can be done before the above mentioned date and time of the next working day.



6. Bids must be valid for a period of 120 days after bids opening and must be accompanied bids security amount at least 3% of the bidding amount (exclusive VAT) on the account no 1310203000000 (Ko. Le. Ne. Ka.) at Rastriya Banijya Bank, Bharatpur or Bank Guarantee on favor of this Hospital from Valid Bank (Class A) in the exact format in the bids document. Bids Security validity period shall be 120 days counting from the date of bids opening.
7. Matters not covered by this notice shall be accordance with procurement act-2063 and prevailing regulation
8. The stakeholder reserves the right to accept or reject the bids wholly or partially any or all the bids without assigning any reason, whatsoever
9. The supplier who has submitted the tender through e-Procurement System must have to submit their documents in the form of hard copy within 3 days from the submission date (e-Procurement System).
10. In case of finding any differences in the softcopy documents submitted through the e-Procurement System and the printed documents submitted to the hospital administration, the supplier will be automatically cancelled for the further competition.
