# Re-Tender Notice

1. Bharatpur Hospital invites Sealed Bid from registered eligible Suppliers having qualification as mentioned in the TOR for the following contract as mentioned below
2. Bidding documents may be purchased from the account section of Bharatpur Hospital, Bharatpur Chitwan by eligible Bidders upon submission of a written request attaching duly attested copies of **Bidder's Firm registration, VAT / PAN Registration with the TAX clearance certificate** up to the Fiscal year 2066 /67 and upon the payment of a non refundable fee as mentioned below on or **before 7 days of date of publication of this notice**. Bidder's representative who wishes to purchase the Bid Documents shall furnish identity letter issued by the authorized person of the firm. For the bidder who will submit their bids in the form of electronic version, should attach the receipt of bid document purchase non-refundable fee deposited in the account stated below
3. The purchase bid documents shall be sealed in an envelope addressing to the Bharatpur Hospital indicating name of Tender Code, Tender Name, bidder's Firm Name and its address. The bid must be submitted to Bharatpur Hospital latest by **12:00 hrs on 7<sup>th</sup>** day of the date of publication of this notice. Documents received after this deadline will not be accepted.

4. The accepted bids shall be opened at Bharatpur Hospital in the presence of the Bidder's Representatives who choose to attend at **14: 00 hrs** on the last date of submission. Non-attendance of any or the Bidder's entire Representative shall not obstruct the opening of the Bids. **For e-Bidders:**

Interested eligible bidders may visit the e-Procurement System Portal of Bharatpur Hospital WebSite: <http://www.bharatpurhospital.gov.np> OR <http://eproc.bharatpurhospital.gov.np/> and may submit their bid electronically through the e-Procurement System using the site mentioned above and as mentioned in the guidelines to the bidders.

5. In case of last date of purchasing of bid documents fall on government holiday then the purchasing can be made on the next working day. Similarly, if the last date of submission falls on government holiday then submission can be done before the above mentioned date and time of the next working day.

6. Bids must be valid for a period of 120 days after bid opening and must be accompanied bid security amount at least 2.5% of the bidding amount (Including VAT) on the account no 41 KHA/3 at Rastriya Banijya Bank, Bharatpur or Bank Guarantee on favor of this Hospital from Valid Bank in the exact format in the bid document. Bid Security validity period shall be 120 days counting from the date of bid opening.

7. The Bidders shall quote the item rates in the bill of quantities exclusive of VAT

8. Bidders are advised to visit the site and assess the actual site condition before submitting their bid

9. Contract will be awarded based on post qualification process satisfying the qualification required as given in bidding data and in the bid documents.

10. Any amendment in the tender / sealed notice shall be published in the hospital and notice section of the website

11. Matters not covered by this notice shall be accordance with procurement act-2063 and prevailing regulation

12. The stakeholder reserves the right to accept or reject the bid wholly or partially any or all the bids without assigning any reason, whatsoever

13. The supplier who has submitted the tender through e-Procurement System must have to submit their documents in the form of hard copy within 7 days from the submission date (e-Procurement System).

14. In case of finding any differences in the softcopy documents submitted through the e-Procurement System and the printed documents submitted to the hospital administration, the supplier will be automatically cancelled for the further competition.
