Government of Nepal has allocated budget towards the cost of procurement of 128 Slice CT Scan Machine and intends to apply part of the funds to cover eligible payments under the Contract for procurement of 128 Slice CT Scan Machine. Bidding is open to all eligible Bidders from all countries as defined in GON Funded projects.
2. The Bharatpur Hospital, Bharatpur, Chitwan invites e-bids from eligible bidders for the procurement of 128 Slice CT Scan Machine **under International Competitive Bidding Procedures.**
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Bharatpur Hospital, Bharatpur, Chitwan, Nepal. at bharatpurhospital.gov.np
4. Bidding documents may be purchased on or before July 6, 2016 from the above office of Bharatpur Hospital, Bharatpur, Chitwan, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/ firm registration certificate, and upon payment of a non-refundable fee of **Nepali Rupees 10,000.00** in cash or in form of bank receipt for fee deposited in GoN revenue account Revenue Title no 131000096701 of Rastriya Banijya Bank Limited, Bharatpur Branch, Bharatpur, Nepal or **US\$. 100.00** in the form of bank draft in favor of Bharatpur Hospital, Bharatpur, Chitwan, Nepal.
5. e-bidding must be submitted as per guideline provided in the tender document. However original document must be submitted to the office of Bharatpur Hospital, Bharatpur, Chitwan before opening of the tender document. Tender opening time is defined as below and also in the SBD. Last date tender submission through e-bidding is before 12.00 hours of 46th days (local time) on July 7, 2016. Documents received after this deadline shall not be accepted.
6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14.00 hrs of July 7, 2016 at the office of Bharatpur Hospital, Bharatpur, Chitwan, Nepal. Bids must be valid for a period of 120 days counting from the day of bid opening and must be accompanied by bid security, amounting to a 2.5% value of the bid, which shall be **valid for minimum 30** days beyond the bid validity period.

7. In the comparison of Bids, Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the instruction to Bidders.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
10. The contract will be valid if the government fund will be available during the contract period.
11. Any provisions which are not mentioned in the notice, refer Standard Bid Document.
